Payment: Land Costs	A deposit of USD <u>\$750.00</u> per person or full payment of USD \$2200.00 per person is required when a reservation is made. All reservations and full payment must be received by 1 April, 2016. Payment is accepted by credit card or check.
Ground Transportation and Hotels	The tour includes ground transportation and accommodations in twin-bedded rooms. Single room occupancy is available for a supplemental cost of \$ <u>400.00</u> . If you do not register with a pre-identified roommate, every effort will be made to identify a roommate for you. If you are notified that a roommate is not available, you will need to pay the single supplement with your final payment.
Meals	Breakfast, lunch and dinner are included daily.
Transport	All transfers for groups of ten or more are included for pick up at airport or border point in Israel and departure , as well as porter service at hotels. A deluxe air-conditioned bus is provided for all tours and transfers. Transfers for individuals or for groups of nine or less will be charged separately USD 130.00 each way.
Sightseeing	Full sightseeing with entrance fees is included for items on itinerary unless otherwise indicated. A licensed, English and Spanish speaking guide will accompany the tour from arrival until departure.

Not Included: Others	Standard tips and items of a personal nature such as drinks at meals, bottled water, laundry, shopping, and offerings in churches, travel insurance, and any service not specifically mentioned are not included. Fuel surcharges and/or tax increases levied since the pricing of this tour are not included. Tour participants may wish to purchase souvenirs of their visit to Palestine. Each participant should consider their personal shopping budget for the trip.
Travel Insurance	HCEF strongly recommends the purchase of travel insurance. Trip cancellation and overseas medical coverage are two important considerations. There are a number of options for such insurance – your own insurance agent may have a recommendation. It is the sole responsibility of the pilgrim to consult with their health insurance provider to determine what international coverage is provided and if supplemental health coverage should be purchased.
Health	Good overall health is necessary to enjoy this experience. Distances walked are moderate, but stair-climbing and being on one's feet can all be tiring. Most international sites are not handicapped or wheel chair accessible. Please consult your doctor if you have any concerns. Please inform HCEF if any member of the group has allergies, special dietary requirements, or any health conditions we must be aware of.
Passports & Visas	A passport valid for at least 6 months from the pilgrimage return date is required. If you do not have a valid passport, contact HCEF as soon as possible . Visas are not necessary for US passport holders to enter Israel/Palestine. Holders of non-US passports must contact the nearest Israeli Embassy/Consulate to determine whether or not they must obtain a visa before departure.
